Power Trading Results in March 2017

In March 2017, the total volume in power derivatives traded and cleared on Nasdaq Commodities amounted to 142.2 TWh (March 2016: 139.6 TWh). The share of Order Book traded power was 79.9 TWh (March 2016: 84.9 TWh) which includes 16.2 TWh from German Power (March 2016: 11.3 TWh).

Electricity Certificates Trading Results in March 2017

In March 2017 the total volume of traded and cleared Electricity Certificates was 1.26 million EI-Certs as compared to 1.14 million EI-Certs in March 2016. The share of Order Book traded EI-Certs was 0.05 million EI-Certs (March 2016: 0.23 million EI-Certs).

Carbon Trading Results in March 2017

In March 2017 the total volume of traded and cleared EUAs was 0.21 million tonnes as compared to 0.15 million tonnes in March 2016.
