Power Trading Results in October 2017

In October 2017, the total volume in power derivatives traded and cleared on Nasdaq Commodities amounted to 114,2 TWh (October 2016: 170.7 TWh). The share of Order Book traded power was 59.6 TWh (October 2016: 106.0 TWh) which includes 12.9 TWh from German Power (October 2016: 17.5 TWh).

Electricity Certificates Trading Results in October 2017

In October 2017 the total volume of traded and cleared Electricity Certificates was 2.07 million EI-Certs as compared to 1.06 million EI-Certs in October 2016. The share of Order Book traded EI-Certs was 0.03 million EI-Certs (October 2016: 0.05 million EI-Certs).

Carbon Trading Results in October 2017

In October 2017 the total volume of traded and cleared EUAs was 0.40 million tonnes as compared to 0.50 million tonnes in October 2016.
