Power Trading Results in February 2018

In February 2018, the total volume in power derivatives traded and cleared on Nasdaq Commodities amounted to 94,7 TWh (February 2017: 104,9 TWh). The share of Order Book traded power was 42,1 TWh (February 2017: 55,1 TWh) which includes 4,4 TWh from German Power (February 2017: 6,6 TWh).

Electricity Certificates Trading Results in February 2018

In February 2018 the total volume of traded and cleared Electricity Certificates was 2.07 million EI-Certs as compared to 1.86 million EI-Certs in February 2017. The share of Order Book traded EI-Certs was 0.06 million EI-Certs (February 2017: 0.08 million EI-Certs).

Carbon Trading Results in February 2018

In February 2018 the total volume of traded and cleared EUAs was 0.06 million tonnes as compared to 0.24 million tonnes in February 2017.
