Power Trading Results in April 2018

In April 2018, the total volume in power derivatives traded and cleared on Nasdaq Commodities amounted to 85,1 TWh (April 2017: 81,0 TWh). The share of Order Book traded power was 40,4 TWh (April 2017: 44,1 TWh) which includes 10,3 TWh from German Power (April 2017: 12,3 TWh).

Electricity Certificates Trading Results in April 2018

In April 2018 the total volume of traded and cleared Electricity Certificates was 1.88 million EI-Certs as compared to 1.38 million EI-Certs in April 2017. The share of Order Book traded EI-Certs was 0.06 million EI-Certs (April 2017: 0.09 million EI-Certs).

Carbon Trading Results in April 2018

In April 2018 the total volume of traded and cleared EUAs was 0.19 million tonnes as compared to 0.05 million tonnes in April 2017.
