Transaction and closing	SEK 2.50 per contract
	No fee is required for stock index options with a premium of SEK 0.10 or less
	Fee is capped at 10 000 contracts per transaction. The fee cap is not applicable to Average Price Trades (APT)
	<p>Volume discount is given in accordance with the following tiers:</p> <p>Tier 1 – A volume discount is given to clearing accounts that has traded more than 21 000 contracts OMXS30 and VINX30 options altogether during one calendar month. The two next coming months, the clearing account pays SEK 2 per contract.</p> <p>Tier 2 – 1 000 000 – 2 000 000 contracts (per calendar year): SEK 0.50, given that the clearing account trades on Tier 1 discount</p> <p>Tier 3 – &gt; 2 000 000 contracts (per calendar year): SEK 0.35, given that the clearing account trades on Tier 1 discount</p>

The fees below are charged members, trading on their own behalf on Proprietary Accounts, who fulfill a liquidity sponsor status. To reach this status the member needs to provide liquidity in accordance with the below. To be eligible, the members need to provide the Exchange with trading ID and agree with the Exchange which instruments that are to be measured. For the months that the member reaches liquidity sponsor status, the member trades at Liquidity Sponsor fees (the discount to proprietary fees is re-distributed monthly). For other months, the member pays fees in accordance with the Proprietary fee list.

Liquidity sponsor fees are only available for products mentioned below. Fees for products not mentioned below are charged according to Appendix 14 Fee list.
