As security for the performance of obligations arising under Contracts for Instruments provided by the Exchange which have been, or may be entered into, with the Exchange and which, according to the Rules and Regulations of NASDAQ OMX Derivatives Markets ("the Rules") in effect at any given time, are recorded or may be recorded on the Member's own Clearing Accounts and Integrated Trading and Clearing Accounts, and Integrated Trading and Clearing Accounts that the member administers, the undersigned (hereinafter Pledgor) pledges to the Exchange the entire content at any given time of the above-stated account with the Custodian Institution, all securities and other rights which at any given time may be held or recorded on the above-stated securities account with the Custodian Institution and all rights which, at any given time, may be recorded on the above-stated CSD accounts and for which the Custodian Institution is account operator in the CSD system.

Income on the pledged collateral as well as other rights arising from the pledged collateral shall be covered by the pledge and shall constitute pledged property.

The Exchange shall have the right to satisfy, from collateral under this pledge, any and all claims it may have against the Member according to the Rules in effect at any given time under Contracts recorded on the Member's Clearing Account and Integrated Trading and Clearing Accounts, and Integrated Trading and Clearing Accounts that the member administers. The Exchange shall also have the right to receive payment from the pledged collateral for costs and work performed in connection with acquisition, maintenance, custody and sale of the pledged property.

All securities deposited by the Pledgor on the securities account or which are recorded on the CSD account shall be deliverable and freely disposable for the Exchange.

The Pledgor grants, through the pledge, to the Exchange or the Exchange's designee the right to sign on behalf of the Pledgor where necessary in order to protect the Exchange's rights under the pledge. This authorization shall be irrevocable for the entire period of the pledge.

The Exchange shall have the right to realize upon the pledged collateral in the manner deemed appropriate by the Exchange.

The Pledgor is aware of the fact and consents that the Exchange is represented by the Custodian Institution in all matters related to the pledge; that the Custodian Institution shall in all respects perform the custody of the pledged property on behalf of the Exchange and shall follow the Exchange's instructions regarding the pledge; that there may be controls of whether sufficient collateral has been pledged in accordance with the Rules in effect at any given time; and that the Custodian Institution may disclose information to the Exchange or its representative regarding the pledged property.

Prior to matters regarding the sale of pledged securities or the satisfaction of claims from the pledged property, withdrawals of securities or other rights from the securities account as well as payments from the account may be made only where the Exchange or the Custodian Institution on behalf of the Exchange, taking into consideration the Exchange's interests as pledge holder, have expressly consented to the Pledgor's request that some or all of the securities and other rights in the securities account or rights in the CSD account be released from the pledge for withdrawal or payment from the relevant account.

This Pledge is a translation from the Swedish original. In the event of conflicting terms, the Swedish original shall have precedence.
